

COVID-19 Related Prevention, Retention, and Contingency (PRC)

EFFECTIVE JULY 1, 2020

You may be eligible for COVID-19 related PRC services if you are a family with a minor child(ren) in the household and meet certain income guidelines.

If you have experienced unexpected expenses related to the COVID-19 crisis and meet family composition, income standards (at or below 200% of the federal poverty guideline), and other criteria, you may be eligible for COVID-19 related PRC Services. Possible services include: assistance with rent/mortgage, utilities, car payment or insurance, one-time family assistance payment (requires verification of order to quarantine), one-time transition back to employment payment to offset employment related incidentals (requires verification of employment), and short term training that promotes employment in a high demand occupation.

CARES Act COVID-19 Recovery Program

EFFECTIVE JULY 1, 2020

You may be eligible for CARES Act COVID Recovery Program if you are a single adult or a couple without minor children in the household, have experienced a job loss or wage reduction related to COVID, meet income guidelines, and other criteria.

If you have experienced unexpected expenses related to the COVID-19 crisis and meet family composition, income standards (at or below 200% of the federal poverty guideline), and other criteria, you may be eligible for services through the CARES Act COVID Recovery Program. Possible services include: assistance with rent/mortgage, utilities, car payment or insurance, one-time family assistance payment (requires verification of order to quarantine), one-time transition back to employment payment to offset employment related incidentals (requires verification of employment).

APS/Senior Citizen COVID-19 Recovery Program

EFFECTIVE JULY 1, 2020

You may be eligible for APS/Senior COVID-19 services if you or your spouse is a senior (60 years +), are at or below 200% of the federal poverty guideline, and experiencing a financial hardship due to the COVID-19 crisis.

If you have experienced unexpected expenses related to the COVID-19 crisis and meet family composition, income standards (at or below 200% of the federal poverty guideline), and other criteria, you may be eligible for services through the Cares Act Covid Recovery Program. Possible services include: assistance with rent/mortgage, utilities, car payment or insurance, or one-time family assistance payment (requires verification of order to quarantine).
